Sealed Tenders in Prescribed Form in Duplicate are invited by the Chief Engineer, KIT from bonafied, reliable and resourceful Contractors having credentials in State P.W.D. / K.M.D.A./ K.M.C./K.I.T. / H.I.T./ C.P.W.D. or similar other organizations as detailed below within last 5 (five) years for the works of same nature.

CREDENTIAL:

- i) Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of 40% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or,*
- ii) Intending tenderers should produce credentials of 2(two) similar nature of completed work ,each of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or,*
- iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i)above;*

In case of running works, only those tenderers who will submit the certificate of satisfactory running works from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i. e., the tenderer.

Other terms and conditions of the credentials:-

- i) Payment certificate will not be treated as credential;*
- ii) Credential certificate issued by the Executive Engineer or equivalent or competent authority of a State/ Central Government, State/ Central Government undertaking, Statutory/ Autonomous bodies constituted under the Central/ State statute, on the executed value of completed/ running work will be taken as credential.*

Intending tenderers will have to apply to the concerned Executive Engineer in duplicate enclosing documents as mentioned in point no. 2 for issue of Tender papers as per date mentioned.

The Tender documents will be available from the Office of the Secretary, General Department at 7th floor, K.I.T. Head Office Building on all working days upto 13-00 hrs till date as mentioned below on payment of non-refundable Tender Paper's cost as mentioned against the work.

The Sealed Tenders should reach the Chief Engineer, KIT before 14-00 hours on the respective last date of Tender dropping.

All applicants must submit Photo Copies of Credential Certificates of successful completion of similar nature of works together with their valid S.T.C.C., P.T.C.C., VAT with their respective Registration Nos. & 'PAN' along with Income Tax Ward /Circle /Range where the Income Tax Assessment is done . The photo copies of Credential Certificates will be verified with the original credential certificates by the concerned E.E. for pre-qualification. I.T. / VAT etc will be deducted as per Rule from the Bills of the Contractors.
3. Labour Welfare Cess will be deducted as per Rules of Bldg. and other construction works Welfare Cess Act, 1996 (Act 28 of 1996).
4. The applicant is required to produce License under the Contract Labour (Regulation and Abolition) Act 1970 at the time of Tender opening.
5. The Contractor is required to provide for adequate safety and welfare measures as per the provisions laid down under Building and other Construction Workers (Regulation of Employment and Conditions of Service) Act 1996 and the West Bengal Building and other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2004.
6. The Contractor is required to abide by the Employees Provident Fund and Miscellaneous Funds Act 1952 and Employees State Insurance Act 1948 wherever such Acts become applicable.
7. The Contractor is required to pay the **Minimum Wages** to the workers according to the rates notified and / or revised by the State Government from time to time under the Minimum Wages Act 1948 in respect of scheduled employments, within the time schedule as specified under the Act. Bonus is to be paid wherever applicable.
