
1. Eligibility Criteria:-
- A. Valid P.T., LT., GST/Sale Tax Registration valid electrical license in favour of the company, in relevant work from Govt. licensing Authority as the case may be and PAN issued by the competent authority.
- B. The Tenderers should have Physically completed/executed similar type of work of value not less than 1/3rd of the quoted amount in a single contract within last three years under Govt./Semi Govt. Undertaking Organization.
