(A) Scope of Works:

- 1. Collection of existing block maps from P & RD deptt, Salt lake counter.
- Collection of existing mouza maps with Dag no. and Batta dag nos. for the area.
- Collection of existing old land use map of concerned area, if available with the SDL&LRO/B&LRO concerned.
- Collection of existing LR or RS (if LR not available) records of concerned area, if available with the SDL&LRO/B&LRO concerned.
- 5. Demarcation of Block, Gram Panchayat & Municipalities in the map.
- 6. Collection of freely available satellite imagery of the area.
- 7. Incorporation of latitude and longitude from Google Earth.
- In the final map each category land, use should represented by a separate drawing layer colour cote for which will be provided by the BDA.
- Field verification of the land use map with Satellite image.
- Incorporation of changes found during field verification and preparation of final land use map.
- 11. Quality checking of the land schedule and Mouza wise maps.

Detail topographical survey (total stations) showing contour at 1.0 m intervals, natural drainage, land slope, pucca/kuchha road, existing structures, power lines, water lines, trees having girth of more than 1'—0" (one foot).
