- iii. Eligibility Criteria: The Bidder will be required to fulfill the following criteria

1. Technical Criteria

The Bidder should have the following minimum Technical experience:

a. The Bidder shall have executed contracts of Design, Engineering, Manufacture, Supply, Procurement, Construction / Erection, Testing and Commissioning of at least of one Ferris Wheel having a minimum height of 80 m in the last ten years from the Bid due date. The Ferris Wheel should be fully operational for a minimum of three year as on the date of submission of bid.

and

b. The Bidder shall have executed at least three contracts of Design, Engineering, Manufacture, Supply, Procurement, Construction / Erection, Testing and Commissioning of Eligible Projects which should have been commissioned in the 5 (five) financial years immediately preceding the Bid Due Date of Rs 150 crores each. The Bidders should also have executed projects involving erection and fabrication of minimum 400 M.T.

In the event the Bidder does not fulfill the requirements of paragraph (a) above, then it shall be entitled to enter into a binding tie up with an agency who fulfills the above requirements and the said agency shall be required to do the detailed design and engineering for the Project and also shall be responsible for development and O&M of the Project for a minimum of 5 (five) years after COD as well as training, transitioning and certifying the operations team which will take over operation of the Project post expiry of

2. Financial Criteria

The Bidder shall have a minimum net worth of Rs.2,00,00,00,000/- (Rupees Two hundred crores) at the close of the immediately preceding financial year. The Bidder shall have reported a net profit in at least 3 (three), out of the 5 (five)preceding financial years. Further, the Bidder shall submit, along with its Bid, a solyency certificate issued for a value of not less than Rs.100 Crores (Rupees one hundred crore only) by any Nationalized Indian Bank/State Bank of India or its subsidiaries/IDBI/ ICICI/ Export Import Bank/Foreign Bank with counter guarantee from any Nationalized Indian Bank or State Bank of India or its subsidiaries/any RBI approved Scheduled Commercial Bank having net worth of more than Rs. 5,000,000,000 (Rupees five hundred crores only) from its Indian operations.

Bidders who meet the minimum qualification criteria as mentioned above will be qualified only if their available bid capacity is more than the total bid value.

3. Assessment of Technical Bid

In addition to above, Bidder who meet the above eligibility criteria and whose bids are found to be responsive will also be assessed on the basis of the Technical Proposal to be submitted as per the requirements defined in the Bid Documents (RFP Documents). Financial bid should be Lump sum contract fee through 'e' tender only.

Bidders attaining the minimum qualifying score of 70 marks in the evaluation of their Technical Bids subject to their being in conformity with the requirement of the project requirements as laid down in the RFP shall be considered to be the Shortlisted Bidders for evaluation of their Financial Bids
