

Superintending Engineer, North Circle, GAP Sector, KMDA invites online tender from reliable, resourceful, bonafide and experienced firms / companies / individual contractors / Joint Ventures / Consortium, who have successfully completed the work of similar nature of works as provided in the Qualification Criteria of Bid Document within last 5 (five) years from the date of this NIT in any Govt. / Semi-Govt. / Govt. Undertakings / Autonomous Bodies / Statutory Bodies and Local Bodies is eligible for the under mentioned work.

1. Qualification requirements as listed briefly below are required to be fulfilled by the bidder. [Bidders are advised to refer to the bidding documents for complete details]

Financial:

- (a) Net worth of INR 187.50 Million in each of the last 3 financial years (i.e. 2013-14 to 2015-16).
- (b) Cash credit facility of INR 75.00 Million.

Technical:

- (a) It has designed, developed, built, tested and commissioned at least one Sewerage Network of 22 Km Length of Sewerage Network including 400 mm diameter pipe or above should be executed during the last 5 years preceding the bid submission date.
- (b) It has designed, developed, built, tested and commissioned at least one Sewage Pumping Stations during last 5 years preceding the bid submission date.

The period of 5 years referred above will be the period from the date of this NIT in any Govt. / Semi-Govt. / Govt. Undertakings / Autonomous Bodies / Statutory Bodies and Local Bodies is eligible for the said work.

2. The Superintending Engineer, North Circle, GAP Sector, KMDA for and on behalf of KMDA in the State of West Bengal, India invites from eligible bidders for the work detailed in the table below. 6. The bid must be accompanied and uploaded by Bid Security of the amount specified in the table above, drawn in favour of GAP Sector, KMDA.
7. Both the Technical Bid and Financial Bid are to be submitted through online.

9. The FINANCIAL OFFER of the prospective qualified bidder (s) will be considered only if the TECHNICAL BID of the bidder(s) is found qualified by Competent Authority of KMDA. The decision of the Competent Authority of KMDA will be final and absolute in this respect.

13. The intending Tenderers are required to quote the rate online.

Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) Minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
15. During scrutiny, if it comes to the notice of the Tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the Tender and that application will be rejected without any prejudice.

16. The Superintending Engineer (North Circle), GAP Sector, KMDA reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
17. Before issuance of the WORK ORDER, the Tender inviting authority may verify the credential and other documents of the lowest Tenderer if found necessary. After verification if it is found that the documents submitted by the lowest Tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.
18. **Submission of Tender:-** a) Pre-qualification/Technical Bid and Financial Bid both will have to be submitted online concurrently duly digitally signed in the website <https://wbtenders.gov.in> as per time schedule stated herein under. Time will be reckoned as per Server Clock. b) The Financial Bid of the prospective tenderers will be opened only if the tenderer qualifies in the Technical Bid. The decision of the Tender Inviting Authority will be final and binding to all concerned and no challenge against such decision will be entertained.
19. **Eligibility criteria for the bidders :-**

- c) Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution through on line at desired location.
- d) Partnership Firm/Consortium should submit necessary deed at desired location through online.
- e) **Joint Ventures will be allowed.**
- Particulars regarding Joint Venture / Consortium as provided in Qualification Criteria of Bid Document within last 5 years from the date of this NIT in any Govt. / Semi-Govt. / Govt. Undertakings / Autonomous Bodies / Statutory Bodies and Local Bodies.
