Photocopy of Tax clearance Challan, work order, payment certificate, Vat registration certificate, G.S.T registration certificate Pan Card, Income Tax return for last three years, Affidaint, Credential certificate, Current Bank solvency certificate duly signed by the applicant with the words "submitted by me".

2. Credential Certificate of successful completion of similar nature of work along with the copies of work order for works completed within last 5 (Five) years of values not less than 50% (Fifty Percent) of the works or including mentioning time of completion of work with payment certificate.
3. Credential of works are in progress or payment certificates will not be entertained.
4. When the applicant is an authorized signatory, he should submit documents of authorization in his favour along with the application.
5. In case of partnership firms, they should submit copy of PARTNERSHIP DEED with their application, otherwise application will not be entertained.
6. In case of "Unemployed "Engineers- Co-operative societies", they shall have to submit all documents in respect of their Society viz. Registration Certificate, Audited Balance Sheet for last 3 (Three) years etc.
7. The tenderers has to submit the above documents duly signed by the intending tenderers in addition he should give written declaration in the form of an "AFFIDAVIT" before Notary as to correctness of the copies of all documents submitted by the tenderer and a declaration of penalty debarment etc. faced by him under any Govt. / Autonomous Body / Institution etc.
