4) *Eligibility criteria for the bidders :-*

A) *The bidders should have the credentials as detailed below:*

Resourceful and bonafide consultancy firms having experience of executing similar nature of works. Intending quotationers should produce credential of preparation of DPR of project cost Rs. 100 Crore for similar nature of work in a single job during last five years. The firm should have one degree Architect with B. Arch and minimum five year experience and one structural Engineer having B.E/ B. Tech. /M.E/ M. Tech with minimum five year experience the firm should submit the credential of work details of organization structure, mentioning qualification and experience of the resource person.

Note:- Preparation of DPR completed and approved from the competent authority will be treated as credential.

- B) Bidder should have PAN card, P. Tax, Valid income tax return (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017 & Latest Valid Trade License, Credentials, Work Order etc.,
- C) One affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution (enclosed format)
- D) **Earnest Money:-** The tenderer shall have to deposit requisite earnest money along with the tender document in prescribed manner failing which the tender shall be rejected. The balance earnest money if any to fulfill 2(two) percent of the tender value is to be deposited at the time of execution of formal agreement.

5) *a) List of common documents shall have to be submitted by each bidder at the time of submission of Quotation:-*

- vii) Affidavit before Notary mentioning the correctness of the documents and declaration of penalty debarment etc.
- viii) Details of Technical Manpower Strength

6) **Site inspection before submission of quotation:**

Before submitting a Quotation, the intending firm/bidder should make themselves acquainted thoroughly with the local conditions prevailing at site of implementation of the work by undertaking field inspections and taking into consideration all probable likely factors and difficulties to be involved in implementation of the work.

- 7) Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by the KMDA during the last 5 (five) years prior to the date of this NIQ. Such debar will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).
- 8) **Bids shall remain valid** for a period not less than 120 days (One Hundred Twenty) from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the period of bid validity the bid money as deposited will be forfeited forthwith without assigning any reason thereof.
- 9) **CONDITIONAL and INCOMPLETE QUOTATION** will not be accepted under a circumstance.
- 10) The Superintending Engineer, Circle-II, KMDA reserves the right to cancel the N.I.Q. due to unavoidable circumstances and no claim in this respect will be entertained.
During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.

List of "Technically Qualified Bidders" will be published in the web portal only. Financial Bid will be opened within a short period after such publication. Therefore Bidders are requested to view the tender status on a regular basis. In case if there be any objection regarding Pre-qualification/ list of "Technically Qualified Bidders", that objection should be lodged to the Chairman, Tender/Bid Evaluation Committee within 24 hours from the date and time of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Tender/Bid Evaluation Committee
- 11) Before issuance of the Work Order, the quotation inviting authority may verify the credential & other documents of the successful bidder if found necessary. After verification, if it is found that such documents submitted by the successful bidder is either manufacture or false in that case Work Order will not be issued in favour of the bidder under any circumstances.
- 12) **Language of Quotation:-** The quotation shall be submitted in English. All literatures and correspondence in connection with the quotation shall be in English.
- 13) Successful bidder shall have to execute an agreement in the prescribe format which will be available from the office.
