- 7. Income tax clearance from I.T. deptt at least for last three consecutive years
- 8. Relevant ISO certification/accreditation
- Company must have Lift Contractor's License of Lift operating upto 1.5.Metre/sec speed of all types of Geared Traction Lifts and 1 metre/sec speed for Machine Room Less Geared / Gearless traction Lifts.
- 10. Company must have a Turn-over of minimum 100(hundred) Lakhs in last three consecutive Years for enlistment in <u>category-1</u> and the turnover should be above 50 lakhs for enlistment in <u>category-11</u>

- 11. Company must have its office & Service Station within Kolkata region minimum 500 Sq.ft covered
- area and its Service Station capable of handling all types of installation & maintenance activities of Lifts.
- Company must have a National Supervisory Competency Certificate (N.S.C.C.)
  Holder supervisor dedicated only for the company and a declaration of that
  Supervisor must be attached with the application.
- Lift License from Lift department, Govt. of West Bengal must be a minimum of 10 (Ten) years old.
- 14. Company must have a Graduate/Diploma Engineer (Mechanical / Electrical) Capable of handling all the above mentioned Lifts erection and maintenance work.
- 15. The manufacturer of lifts must have requisite credential of completion of supplying, installation, commissioning of lifts at any Government department/ Educational Institutions of repute/ corporate houses/Renowned hospital buildings during last five years.
- 16. A written declaration in the form of Affidavit before Notary as to correctness of all documents submitted and a declaration of penalty /debarment etc. faced by them if any.

The Lift Manufactures who are already approved under category—I & category-II need not to apply for enlistment. However those who are approved in category-II can apply for up gradation from category-II to category-I
