4. GST Registration Certificate clearance certificate and upto date Trade License.
5. Valid Electrical contractor license.
6. Supervisor competency (S.S.C. part I, 2, 4, 7A, 7B, 11)
7. A written declaration on letterhead duly signed as to correctness of all documents submitted and a declaration of penalty /debarment etc. faced by them. After scrutinizing all above documents department will issue tender documents if those documents are found in order.

Tenderer shall mention their offered rate in percentage ABOVE or BELOW or AT PAR of the departmental estimated amount put to tender in proper position of the documents both in figure and words written in indelible ink and in English scripts..


