Tax, Valid income tax (For Last 3 yrs), VAT/GST clearance certificate, Credentials, Work Order; Payment certificate, Bank Solvency Certificate in Current Financial Year and other supporting documents, Registration Certificate and/or trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.

c) Scanned Copy of one original affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution through on line at desired location.

f) **Earnest Money:-** The tenderer shall have to upload scanned copy of original requisite earnest money along with the tender document in prescribed manner failing which the tender shall be rejected.
